- IEP Verification and Accommodation <u>Form</u> must be emailed to Competitive Event Director at dnied<u>ringhaus925@gmail.com</u> by January 12, 2024.
- Provide a link to a five (5) minute prepared speech.
 This link must be pasted in the new Digital Upload System making sure it is sharable to all. This is what the judges will use to judge virtually.

Event Summary

Speaking Skills provides HOSA members with the opportunity to improve knowledge and skills surrounding effective oral communication. This competitive event requires competitors to develop a speech related to a selected national topic. The topic for the year aligns to the HOSA membership theme, which is announced at the conclusion of the International Leadership Conference every year. This event is specifically for HOSA members who are classified under IDEA.

2023-2024 Topic: Dare to Create!

Dress Code

Competitors must be in official HOSA uniform or in proper business attire. Bonus points will be awarded for proper dress.

Competitors Must Provide □ Eligibility form (submitted by state deadline per state's process AND digitally submitted for ILC prior to May 15th) □ Photo ID □ Paper or electronic notes (optional) □ Two #2 lead pencils (not mechanical) for evaluation

IEP Events

Four (4) events in the HOSA Competitive Event Program are designed for students classified with an HOSA Speaking Skills Guidelines (August 2023)

IEP. The events are Interviewing Skills, Personal Care, Life Support Skills, and Speaking Skills

Participation Eligibility: To participate in these four events, the competitor MUST be classified under the provision of the 2004 reauthorized Individuals with Disabilities Education Act (IDEA). Students classified under Section 504 are NOT eligible to compete in this event.

IEP Verification and Accommodation: This form must be completed by all competitors in these four (4) events to be eligible for ILC competition. This form also allows the competitor to request accommodation. To learn the definition of an accommodation, please read Appendix H.

Point Deduction: If the competitor does not submit <u>this form</u> by the May15 deadline, then the competitor will be allowed to compete but will receive 35 penalty points. Points will be deducted in Tabulations. **Deadline:** . The deadline for ILC is May 15 midnight EST.

State Level Process: To request accommodation and verify eligibility for any regional/area or state level conferences, please work with your local and state advisor directly. Accommodations must first be done at the state level to be considered for ILC.

General Rules

- 1. Competitors in this event must be active members of HOSA and in good standing.
- 2. **Eligible Divisions:** Middle School and Secondary division members are eligible to compete in this event.
- 3. Competitors must be familiar with and adhere to the <u>"General Rules and Regulations of the HOSA Competitive Events Program (GRR)."</u>
- 4. All competitors shall report to the site of the event at the time designated for each round of competition. At ILC, competitor's photo ID must be presented prior to ALL competition rounds.

Competitive Process

- 5. Use of index card notes during the speech is permitted. Electronic notecards (on a tablet, smart phone, laptop, etc.) are permitted, but may not be shown to judges.
- 6. The prepared speech shall be a maximum of **four (4) minutes** in length.
- 7. The timekeeper shall present a flash card advising the competitor when there is one (1) minute remaining. The competitor will be stopped when the four minutes are up and be dismissed.
- 8. All competitors shall speak on the same announced topic.
- 9. Props may NOT be used.
- 10. There will be no microphones used for this event.

Final Scoring

- 11. In the event of a tie, a tiebreaker will be determined by the areas on the rating sheet section(s) with the highest point value in descending order.
- 12. If the competitor does not complete the <u>Eligibility Form</u> by the deadline, then the competitor will be allowed to compete but will receive 35 penalty points. Points will be deducted in Tabulations.
